## Become a Mediator or Refresh Your Mediation Skills as Part of the CAI-NJ Alternative Dispute Resolution Program

Mediation is a non-adversarial approach in which a neutral party, the mediator, guides disputing parties through the resolution process to reach a mutually acceptable agreement. CAI-NJ is hosting the Mediation Training Program and is limited to 15 registrants to fill the critical need of providing affordable mediation services by persons who are experienced in community association matters.

### ABOUT THE CHAPTER ADR PROGRAM:

By successfully completing this Mediation Training Program you will be placed on the CAI-NJ list of mediators for the chapter's ADR Program. Being on the list of qualified mediators allows you to be chosen to mediate community disputes through the CAI-NJ ADR Program. Each registrant will receive a certificate of completion which will also be kept on file at the office of CAI-NJ. Mediators will be compensated with a \$200 stipend per mediation completed.
