COVID-19 SAFETY INFORMATION. While participating in events held or sponsored by the New Jersey chapter of Community Associations Institute (CAI-NJ), “social distancing” must be practiced, and face coverings are always worn to reduce the risks of exposure to COVID-19. 2. Individuals who have traveled at any point in the past fourteen (14) days either internationally or to a community in the U.S. that has experienced or is experiencing sustained community spread of COVID-19; or
3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

SAFETY GUIDELINES NON-COMPLIANCE. Failure to comply with CAI-NJ, the State of New Jersey, or Federal health guidelines may result as follows:

1. If my temperature, when taken before entering a CAI-NJ event, is above the safe range, I will not be permitted to attend the event and will receive a refund for my registration fee; and
2. If I fail to comply with the CAI-NJ Event Reopening Guidelines, it will result in my removal from the event and potentially being banned from future CAI-NJ events as determined by the CAI-NJ Board of Directors.

EVENT PARTICIPANT RELEASE AND WAIVER.
